Voting was 53 done by silent ballot. Those votes were handed to Jordan Chase, Board member, student 54 delegate. Jordan Chase then read the votes out loud and Wanda Laducer wrote the 55 names of the applicants on the board and put a mark by the name of the person who got 56 the vote. The board determined that the two applicants with the highest amount of 57 votes would advance to the next round. After the first round of voting was completed 58 the votes were as follows: Roland Desjarlais received five votes, Dennis DeCoteau 59 received 1 vote, Charles Delorme received four votes, Carla Peltier received five votes. 60 Roland Desjarlais and Carla Peltier received the most votes. The board voted again on 61 a piece of paper by silent ballot, this time only voting for either Carla Peltier or Roland 62 Desjarlais. Jordan Chase picked up the ballots and read them out loud with Wanda 63 Laducer writing the results on the board.
